**MUST PRESENT
RV/CAMPER REGISTRATION,
ID CARD & INSURANCE**

ELIGIBILITY

Eligible members may make reservations 90-days in advance.

Active duty and retired military, Reserves, Guard, 100% Disabled American Veterans (DAV), Veteran Health Identification Card (VHIC) vets.

Family and guests may be sponsored by eligible users.

Maximum stay is one month per registered stay. Maximum 180 days per calendar year IAW AFI 34-101.

Contractors are **ineligible** users. Inquire on sponsored guest; current security precautions may prevail.

(*DoD ID card holder and sponsored guest MUST be present to make a reservation and to check-in)

All patrons MUST bring RV registration at check-in time.

NON-MILITARY GUESTS

(DoD ID card holder must be present to fill out paperwork)

Fees and charges for non-military guests will be at a higher rate than eligible Active Duty, retiree, and DoD members.

VA Veterans Health Identification Card (VHIC) members must check with JBSA-Fort Sam Houston Visitor Center for details on additional guest permits/access to the installation. The JBSA-Fort Sam Houston FamCamp RV Park does not sponsor additional guests.



CAMPGROUND POLICIES

Campers MUST use a water pressure regulator attached to faucet end of hose due to very high water pressure in the campground.

- No bird or animal feeders allowed, as they attract other animals.
- Children ages 12 and younger must be accompanied by an adult at all times.
- Helmets must be worn when riding bikes on the post.
- Limit two vehicles per RV site.
- Limit eight people per RV site.
- Sponsors are responsible for the safe and proper conduct of their dependents and guests at all times.
- Quiet hours: 10 p.m. to 7 a.m.

PLAY AREA



PET POLICY

- Pets must be on a leash at all times or in a pen/leashed and accompanied at all times when in the RV park - NO EXCEPTIONS
- Leashes must not exceed 10 ft
- No more than four pets per site
- Pets must never be left outside without owner present
- Visual accompaniment from RV is not permitted.
- Pickup after pets IMMEDIATELY, no exceptions
- Pets are not allowed in restrooms or office
- Barking must be kept to a minimum
- Pets must be registered at the Vet Clinic if stay exceeds two weeks. Contact Vet Clinic at (210) 808-6101

FIREARMS POLICY



FIREARMS ARE NOT PERMITTED ON JBSA-FORT SAM HOUSTON GROUNDS

All firearms must be declared at the Entry Control Point before entering Fort Sam Houston. Firearms must be taken to a secured location until the owner departs JBSA-Fort Sam Houston.

SPEED LIMIT IS 5 MPH
